I understand that these risks can range from minor injuries to major injuries including death. In consideration of my participation in the activities and use of the facilities offered by Sun Capsule Tan & Tone, I understand and voluntarily accept this risk and agree that Sun Capsule Tan & Tone, its officers, directors, members, agents and independent contractors will not be liable for any injury, including, without limitation, personal, bodily, or mental injury, economic loss or any damage to you, your spouse, domestic partner, guests, unborn child or relatives, resulting from the negligence, if any, of Sun Capsule Tan & Tone or anyone on the behalf of Sun Capsule Tan & Tone whether related to exercise or services or not. Accordingly, I do hereby and discharge Sun Capsule Tan & Tone from any and all claims, demands, injuries, damages, actions or cause of action indefinitely.

EQUIPMENT & MEMBERSHIP: I further understand and acknowledge that Sun Capsule Tan & Tone does not manufacture fitness or other equipment in its facilities, but purchase and/or lease equipment and therefore Sun Capsule Tan & Tone may not be held liable for defective products and or equipment. Sun Capsule Tan & Tone may, in its sole discretion, modify the policies or any facility/club rule without notice at any time. Sun Capsule Tan & Tone reserves the right not to refund any product and or membership or services at any time. If a refund is given, only the prorated cost of the unused services will be refunded.

Sun Capsule Tan & Tone may terminate memberships immediately for violation of any membership policy or facility/club rule. I understand that memberships and services are non-transferable and must be used within the designated service time. Pre-paid gift cards or credits to memberships and services must be used within 90 days from purchase date or credit allowance date.

TANNING RELEASE & WARNINGS: DANGER- ULTRAVIOLET RADIATION: FAILURE TO USE PROTECTIVE EYEWEAR MAY RESULT IN SEVERE BURNS OR LONG TERM INJURY TO THE EYES.

* Avoid too frequent or lengthy exposure. As with natural sunlight, exposure to a sunlamp may cause eye and skin injury, sunburn and allergic reactions. Repeated overexposure may cause chronic damage characterized by wrinkling, dryness, premature aging of the skin and skin cancer. We recommend that you do not tan outdoors on days you are tanning indoors, that you do not tan if you currently have a sunburn and that you, at most, tan only once in a 24 hour period. Use of a tanning device may not provide a protective base in regards to sun exposure.

* You are required to wear protective eyewear and use eye protection every time you tan. (must provide own eyewear).

* Abnormal or increased skin sensitivity or burning may be caused by certain foods, medications (including but not limited to tranquilizers, diuretics, antibiotics, high blood pressure medication, birth control pills and skin creams), cosmetics and toiletries. Consult a physician or pharmacist before using a sunlamp if you are using prescription or non-prescription medications, have a history of skin problems, or believe yourself to be especially sensitive to sunlight. Pregnant women and women on birth control pills who use a tanning device may develop discolored skin.

* Ultraviolet radiation from sunlamps enhances the effects of the sun. Do not sunbathe before or after exposure to ultraviolet radiation. If you do not develop a tan outdoors, you are unlikely to tan from the use of any tanning device or product.

* Tanning lotion is for external use only. The products we sale do not contain sunscreen and will not protect against sunburns. Repeated exposure of unprotected skin while tanning may increase the risk of skin aging, skin cancer, and other harmful effects to the skin even if you do not burn. Discontinue any product that causes any type of irritation.

MY UNDERSTANDING & RELEASE: I verify with my signature, that I am 18 years of age or older as required by law. I understand the content of this consent form I carefully reviewed and state that I am not aware of any medical condition or other reason that would prohibit me from tanning or toning. I have been given adequate instructions for the proper use of the tanning and toning equipment, understand the risks involved and use it at my own risk.

I hereby agree to release the owners, agents, operators, contractors, all affiliates and manufacturers from any damages that I might incur due to the use of the facility.
